## **Include Me Preschool**

- 1. Lisa Snyder attended 4 LICC (Local Interagency Coordinating Council) meetings. All meetings took place through a virtual platform: ZOOM. The meetings were Lancaster, Montgomery, Bedford, and Franklin Counties. Lisa continued to share information on Include Me Preschool's role in family engagement and other program updates.
- 2. Lisa Snyder participated in the April SICC (State Interagency Coordinating Council) meeting. Lisa cofacilitated a family 'meet and greet' before the SICC meeting with 12 families in attendance.
- 3. Lisa Snyder assisted in the facilitation of three family Vitality Cafes. Each café was the same topic presented to different family groups. Lisa led family discussion groups.
- 4. Lisa Snyder presented to the EITA (Early Intervention Technical Assistance) inclusion cohort. Lisa shared information on family engagement, LICCs, and the Include Me Preschool program.
- 5. Lisa Snyder participated in the Pennsylvania 2021 Early Intervention and Family Support Program Conference. Lisa presented on the Life Course framework with EITA and one other family member. Lisa shared her personal experience with the framework.

## Include Me School Age (IM)

- 1. District support needs continued to evolve throughout the school year and requests for support continues to grow. Planning for next school year continues. To date, the following districts/schools have submitted confirmation to continue next school year: Bloomsburg, Council Rock, Cumberland Perry Vo-Tech, Delaware Valley, Northampton, Mercer Area, Pittsburgh Public, School District of Philadelphia, and West Shore. Nicole Turman has been meeting with additional districts for participation next year. The following districts have planned participation: Benton, Easton, West Mifflin School District and Midd West. Millersburg, Pequea Valley, and Cornwall-Lebanon have all expressed some level of interest and outreach/follow-up continues with those districts.
- 2. Sherri Landis, Nicole Turman, and Jill Craig worked with Kim Herb to develop the Trauma Informed Care/Behavior Support e-learning module and it is posted on the website.
- 3. The Arc of PA's application as an Act 48 provider was approved by the Pa Department of Education. We can offer Act 48 credit for our professional development training, e-learning modules, book studies, and the Intentional Teaching full day training. The first professional development training for an IM school district for Act 48 credit is scheduled for May 18th.

- 4. Planning for a Summer Institute to provide 3 days of training on inclusive practices for Act 48 credit continues. The Institute will be held June 22-24th and includes a combination of keynote speakers and The Arc of PA sessions each of the three days. Topics include: Trauma informed supports in the classroom; Presuming competence; Equity by design.
- 5. Jennifer Billig continues facilitation of a second round of the book study on "Out of My Mind" by Sharon Draper. A second book study on the book "Fish in a Tree" has begun and is being facilitated by Jennifer Mulle, Celia Morrison, and Lisa Butler.
- 6. Program specialists are delivering end of year professional development sessions, planning for requested supports over the summer, and working with continuing districts to plan supports for the 2021-22 school year.

# **ADEPT - Arc Discovery Employment Transitions**

ADEPT staff continued work related to Discovery and Customized Employment with the following activities highlighted:

- 1. Action with the Office of Vocational Rehabilitation (OVR)
  - ACRE (Association of Community Rehabilitation Educators) trainings were delivered via Zoom March 22-24th and April 28-30th. An ACRE training is scheduled for May 17-19 via Zoom. These trainings continue to be offered outside any Office of Vocational Rehabilitation (OVR) training contract. The remaining trainings for this fiscal year are scheduled as follows: May 17-19 and June 14-16. After receiving feedback from the ACRE team, Nicole Turman and Jen Hipps made the revisions to the ACRE curriculum to submit for ongoing approval to deliver the ACRE certificate training via distance learning beyond June 30, 2021.
- 2. Action with the Office of Developmental Programs:
  - Nicole Turman, Anthony Chan, and Jen Hipps presented Discovery Certification training via remote learning April 19-21, 2021.
  - Nicole Turman, Anthony Chan, and Jen Hipps presented Marc Gold & Associates online Customized Employment (CE) Job Development training April 12-14th. The ADEPT will be mentoring the certification candidates from this cohort through CE Job Development certification activities.
  - The ADEPT team developed content for an e-learning module on Customized Employment which has been sent to Kim Herb for development. This module will provide those seeking their re-certification with a review of the content. Additional modules related to CE are being developed.
- 3. Action with the Department of Education:
  - ADEPT continue to attend bi-weekly ZOOM program meetings with IM staff to facilitate coordination of efforts and support. Program staff are working together to deliver and develop professional development training, conduct outreach, and support student teams including development of new tools, resources, and training specific to transition and employment.
  - ADEPT consultants have maintained communications with participants, families, school districts, and OVR counselors. As counties moved to phased openings and schools begin to resume more activities, ADEPT consultants and Jen Hipps maintained contact with participants, employers, and funders to determine preparedness to return to work/services and transition-based work experiences. Jen had a meeting with Benton School District they have requested participation in Include Me, including supports for student transition teams using Discovery and CE to develop customized work experiences.
