## What is a Medically Underserved Population?

A "medically underserved population" (MUP) is a population group designated by the Secretary of the Department of Health and Human Services (HHS) as having a shortage of certain healthcare services.

## What are the benefits of a MUP designation?



#### A MUP designation unlocks access to:

- Grants to support primary care services;
- Applies to medical, dental, and behavioral health care;
- Provider loan-repayment programs;
- Grants to support health research;
- Support for training and recruitment of health professionals;
- Enhanced payment for FQHCs and Look-A-Likes meeting requirements under §330 of the PHS Act.



#### Why is the MUP a health equity tool?

#### People with disabilities experience health disparities.

- Disparities are differences in health between people with and without disabilities;
- They are caused by a history of social, economic, and environmental discrimination; and
- They are avoidable.

#### Paths to a MUP designation



- A population may be designated as Medically Underserved in one of three ways:
- The President may make the designation by Executive Order.
- The Health Resources and Services Administration (HRSA) or the Secretary of HHS may make the designation by
  - Meeting HRSA's requirements; or
  - Applying for a Governor's Exceptional designation
- Congress may pass a law making the designation

## What is an Exceptional Medically Underserved Population (EMUP)



The Public Health Services Act (PHSA) allows a Governor to apply for an Exceptional MUP designation to address healthcare access disparities when a population group, such as people with developmental disabilities, does not qualify under the current Index of Medical Underservice (IMU) formula due to unusual local conditions in a state.

In Pennsylvania, Achieva's Disability Healthcare Initiative is working with Governor Shapiro's office to obtain this designation for all Pennsylvanians with disabilities.

# What is a Special Medically Underserved Population (SMUP)?



A Special Medically Underserved Population (SMUP) designation is a kind of MUP designated explicitly by Congress under the Public Health Services Act (PHSA).

The Achieva Disability Healthcare Initiative is also working with Members of Congress and federal partners to obtain a federal designation for people with disabilities.
