"I DON'T GET THE CARE I NEED": EQUITABLE ACCESS TO HEALTH CARE FOR MAINERS WITH DISABILITIES (pdf – DRME.org)

In 2022, DRM formed a Health Equity Work Group to identify systemic approaches to removing barriers and improving access to health care for people with disabilities across Maine. In doing this, one issue became glaringly apparent: there was a lack of data to characterize the issues that Mainers with disabilities face when seeking health care. DRM's Health Equity Work Group sought and received funding from the Maine Health Access Foundation to conduct a project to gather data and produce a report on barriers to health care for people with disabilities in Maine.

Key learnings from COVID-19 to sustain quality of life for families of individuals with IDD (Journal of Policy and Practice in Intellectual Disabilities)

COVID-19 has very publicly had profound impacts on the health system of every country in the world. Over 4.5 million people have lost their lives. School closures worldwide where up to 1.6 billion of the world's children have been out of school, are also prominent in world news. Behind these public impacts are the families. In this paper, we focus on the experiences of families with people with intellectual and developmental disabilities (IDD) through analysis of two data sets: the emerging research literature and contributions from our author team who have lived experience of intellectual and developmental disability in the context of COVID-19. From these two data sets, we discern five themes of the impact of the pandemic: on health, on education, on services and supports, on families and finally on relationships beyond the family. We conclude with lessons from those living with intellectual and developmental disabilities, the caregivers and the individuals themselves to draw implications for supporting families in the context of disability during future pandemics.

Healthcare Access for People with Disabilities in Rural PA (pdf)

This report features stories from people with disabilities, their family members and caregivers about barriers to healthcare access. We collected these stories through surveys, face-to-face meetings, phone conversations, and public listening sessions during 2019 and 2020. Perhaps the least measured and understood aspect of COVID's imprint on the workplace is that of the condition known as long COVID. Long COVID can include a wide range of ongoing health problems that can last weeks, months, or years. With such a new disease, the long-term outcomes are truly unknowable at this point.

Disparities in Health Care in Medicare Advantage Associated with Dual Eligibility or Eligibility for a Low-Income Subsidy and Disability

This report presents summary information on the performance of Medicare Advantage (MA) plans on specific measures of quality of health care reported in 2021, which corresponds to care received in 2020. Specifically, this report compares the quality of clinical care for four groups of MA enrollees that are defined based on the combination of two characteristics: (1) dual eligibility for both Medicare and Medicaid or eligibility for a Part D Low-Income Subsidy (LIS) and (2) disability.

Long COVID Syndrome Presenting as Neuropsychiatric Exacerbations in Autism Spectrum Disorder: Insights for Treatment

COVID-19 causes not only severe respiratory symptoms, but also long-term sequelae, even if the acute-phase symptoms are minor. Neurological and neuropsychiatric symptoms are emerging as major long-term sequalae. In patients with pre-existing behavioral symptoms, such as individuals with autism spectrum disorders (ASD), the emergence of neuropsychiatric symptoms due to long COVID can be difficult to diagnose and manage.

National Roadmap for Disability-Inclusive Healthcare (https://www.inclusivecareroadmap.org/)

The National Roadmap for Disability-Inclusive Healthcare (the Roadmap) is a plan created for clinicians to give the best healthcare possible to people with intellectual and/or developmental disabilities (IDD).

The Roadmap provides clear goals and commonsense actions that different groups can take to inspire change among both practicing clinicians and clinicians-in-training.

NIHCM Infographics

People with disabilities have been uniquely impacted by the pandemic as they face a greater risk of poor health outcomes, reduced access to routine services and care, and adverse social outcomes. Individuals with disabilities were more likely to face unemployment during the pandemic and those with intellectual and developmental disabilities were six times as likely to die from COVID-19 than other people. Additionally, people with disabilities experienced disparities in the public health response to COVID-19 due to lack of appropriate data collection and accessibility barriers in information, testing and vaccination. This infographic highlights the challenges facing the disability community as well as clear steps that can be taken to support the health and well-being of this community.

Pennsylvania counties with the most racial and ethnic diversity in 2020 Census

The U.S. Census Bureau has released some of the first detailed numbers from the 2020 Census. Hundreds of thousands of data points were released just for Pennsylvania. Note that the diversity index doesn't measure white versus non-white, or Hispanic versus non-Hispanic. It measures the variety of backgrounds within each racial group. Two counties that are 85% white could have different diversity indices if the backgrounds of the white people are a mixture of English, Italian, Turkish, Hungarian and Peruvian, for instance. The index will also increase the more racial groups are represented in the 15% of the non-white population, including Blacks, Pacific Islanders, Native Americans, Asians, etc.

People-First Language

People-first language is used to communicate appropriately and respectfully with and about an individual with a disability. People-first language emphasizes the person first, not the disability. For example, when referring to a person with a disability, refer to the person first, by using phrases such as, "a person who ...", "a person with ..." or, "person who has ..."These are some general tips you can follow.

People with Intellectual/Developmental Disabilities(I/DD): Telehealth Overview (Resources for Integrated Care – 2/2023)

Telehealth has been increasing in popularity and usage in the US healthcare system over the past 12 years. 6 However, despite marked strides in increasing access for older adults and individuals in rural areas, it wasn't until the COVID-19 PHE that many organizations and policymakers realized the positive impact telehealth could have on individuals with I/DD.

This study, which analyzed fact sheets for three of the major U.S. vaccine manufacturers and other informational material, found that most of the COVID-19 vaccine-related informational materials did not meet appropriate readability levels for the U.S. population.

This beautiful complexity demands a healthcare system that conforms to whole persons and individual needs, and not the other way around.
